

Memorandum of Understanding for the Exchange of Students

between

Government Degree College Gandachera , Dhalai, Tripura

and

Adwaita Malla Barman Smriti Mahavidyalaya, Amarpur

The purpose of this Memorandum of Understanding (MOU) is to establish an affiliation between Government Degree College Gandachera and Adwaita Malla Barman Smriti Mahavidyalaya, Amarpur for the purpose of a student exchange agreement.

PARTICIPATING PARTIES

- I. Government Degree College Gandachera
- II. Adwaita Malla Barman Smriti Mahavidyalaya Amarpur

TERMS OF THE MOU

GENERAL REGULATIONS, ELIGIBILITY AND ENROLMENT

1. The two parties agree to enter into a student exchange agreement, commencing in the academic year 2019
2. The participating students will register at the host institution for minimum one week academic program.
3. Each institution may send up to 25 students per academic year to participate in the exchange for one or two weeks rather than a full academic year. The number of participants may be increased subject to the mutual agreement of both institutions..
4. It is expected that in any given time period there will be an equal number of students exchanged from each institution.
5. The candidates will be students who will be completing an undergraduate program at their respective institutions.
6. The candidates will be selected by their respective institutions to participate in the exchange.
7. Participants in the exchange will be required to have completed at least one week.
8. Each institution will appoint a faculty member to act as the coordinator for the exchange.
9. The host institutions will have the right of refusal of any candidate who may appear to be unacceptable for the exchange. Each sending institution will follow the exchange application deadlines set by the receiving institution.

FINANCIAL ARRANGEMENTS

10. The host institution will bear the expenses needed for the exchange program and make appropriate arrangements for the food and lodging of the students.

REGULATIONS AT THE HOST INSTITUTION

11. At the end of the exchange program the participants in the exchange will request the host institution to send to the home institution a report/official transcript of their academic achievement.
12. Exchange students are subject to the rules and regulations of the host institution. The host institution reserves the right to dismiss any participating student at any time for academic or personal misconduct. The dismissal of a participant shall not abrogate the agreement for the arrangements regarding other participants.

DURATION, AMENDMENT AND TERMINATION OF THIS AGREEMENT

13. The parties will review the terms of the MOU annually to assess the success of the exchange, and will determine whether to continue, modify or discontinue the MOU. Each party reserves the right to terminate this MOU upon six months written notice to the other. Any exchanges of students taking place at the time of termination will not be affected; exchange students who already stay at the host institution will be allowed to complete the exchange program.
14. This MOU shall take effect when signed by both parties, and will remain in effect for a period of one year. Thereafter, it has to be renewed for another period.

Memorandum of Understanding (MoU)

Between

1. **Parties :** This Memorandum of Understanding (herein after referred to as MoU) is made and entered into by and between the Government Degree College Gandacherra whose address is Maskumbir, P.O. Gandacherra, District- Dhalai, State-Tripura, PIN 799284 and Adwaita Malla Barman Smriti Mahavidyalaya whose address is Kawamaraghat, P.O. Amarpur, District Gomati, State Tripura.
2. **Purpose:** The purpose of this MoU is-
 - (a) To establish terms and conditions under which the two institutions will exchange faculties for delivering lecturers on different topics for the benefit of the students.
 - (b) To set rules under which the two institutions will exchange faculties for participating in seminars, symposiums and other types of academic discussions.
 - (c) To conduct study tour and joint consultancy work
3. **Terms of MoU:** This MoU is effective from 01-07-2019.....and will remain in force and effect for not longer than one academic year i.e up to 01-07-2020. This MoU may be terminated without cause by either party by a written notice that may be delivered by hand or by certified mail to the address mentioned above.
4. **Responsibilities:** The host institution will bear the expenses of the faculty exchange program in a convenient way.
5. **General Provisions:** Either party may request changes to the MoU. Any Changes, modifications, revisions or amendments to this MoU which are mutually agreed upon by

and between the parties shall be incorporated by written documents and effective when
executed and signed by two parties to this MoU.
