## Adwaita Malla Barman Smriti Mahavidyalaya Amarpur, Gomati Tripura

### A Brief History:

As a matter of fact, Amar Manikya, a well-known Manikya ruler of Tripura was associated with this land. Government Degree Collage, Amarpur as a co-educational institution of higher education was established on 13<sup>th</sup> September 1988 to meet the emerging need of students and local people. Initially, the college started its function in the school building of Govt. Higher Secondary School for boys at Amarpur in the morning shift. Later on, the location of this college was shifted to present site of Kawamara, Amarpur, Gomati Tripura district on 12 December 2002. This college has received recognition from the University Grant commission (UGC) under 2(f) and 12(B) on 17 Nov 2009. The college has been renamed as Adwaita Malla Barman Smriti Mahavidyalaya in the year 2014.

At present, the college has been offering three-year degree programme in Arts both in Honours subject such as Bengali, English, Sanskrit, Education, History, Political Science and philosophy and Pass in above mentioned subjects including Kokborok. Science Stream (Pure Science) Pass course has been introduced in the year 2016 with intake capacity of 10 students. UGC sponsored programme such as Remedial coaching cell for SC/ST/OBC students, Career and Counselling cell, coaching for first service entry in service are functioning for the betterment of the students in the field of higher Education.

**Aim of the college:** To deliver education to the students and to use modern Technology in delivering lectures in the classroom.

**Vission:** To establish A.M.B.S.Mahavidyalaya, Amarpur, a highest institution of the quality education in the state.

**Mission:** The mission of the college is to introduce both Science and Commerce stream along with others subject of Arts (including the existing subjects) and to open Profession-Oriented courses like BCA, DCA, Fashion Technology and traditional tribal handloom technology etc. in the A.M.B.S.Mahavidyalaya, Amarpur with modern technology, so that after getting the degree/diploma students to not face any difficulty to avail service/business.

A.M.B.S.Mahavidyalaya, Amarpur, formmmerly Known as Govt. Degree College, Amarpur, established in the year of 1988, is a brainchild of the government of Tripura, Department of Higher Education, for spreading an availing higher education to the remotest hilly area of the state, particularly to left out of the tribals and non-tribals of the forest area of Tripura. ## RULES AND REGULATION FOR ADMISSION

1. Any student passing H.S.(+2) examination or its equivalent with at least 4 subjects including English from any recognized Board/Council shall be eligible for admission to the 1<sup>st</sup> Semester of the B.A(Honours/General)/B.Sc(General) Programme of studies subject to availability of seats and restrictions of combinations of subjects as laid down in Clause-5 and provided that he/she has secured in that examination, at least,
  - a. 40% marks in aggregate and 45% marks in the subject in which he/she seeks Honours.

Or
  - b. 35% marks in aggregate and 50% marks in the concerned subject (Group & Course).

Or
  - c. Any one securing at least 50% marks in aggregate shall be eligible for taking Honours in a subject, which he/she did not study in H.S.(+2) examination or its equivalent, subject to restriction of combination of subjects.

(In regards to marks bar for admission against reserve seats / quotas for ST/SC/PH/OBC candidates the guidelines/instructions of UGC will be followed from time to time.)
2. No student shall be allowed for admission into 1<sup>st</sup> Semester course for studies after a lapse of more than 5(Five) years from the year of passing the previous qualifying examination.
3. A student shall not be allowed to take Honours in a subject in which he/she has failed in H.S.(+2) examination or its equivalent but subsequently passed as a compartmental candidate.
4. A student shall not be allowed to offer more than two language subjects as elective. However the college authority may further restrict the choice of combination of subjects according to the infrastructural facilities and faculties available in the concerned college.
5. Subject taken as Honours shall not be taken as an elective subject.

6. A student shall have to apply with 1 copy of recent Passport size photo for University registration in prescribed form within 30 days from the last date of admission. No application for registration will be entertained after the expiry of this stipulated period.
7. A student shall be allowed to change subjects(s)/stream within 15 days from his/her admission to the college, subject to the restriction of combination of subjects laid down by the respective college. No such change shall be entertained once application for University registration is forwarded to the University from the college.
